




Clinical education "activities" and "must to knows":







Blended learning models:

- 1. Rotation Model
- 2. Flex Model

- 3. A La Carte Model
- 4. Enriched Virtual Model





Rotation Model


- Learners rotate between learning modalities.
- Most of the learning still occurs on a physical campus.
- The Flipped Classroom is the most classic example.





Flex Model

- Learners switch between learning modalities on a customized, fluid schedule
- E-Learning is its backbone.
- It gives students a high degree of control over their learning.





A La Carte Model

- Learners take online courses in addition to their face-to-face ones.
- It is a great option elective courses.





Online Teacher







Enriched Virtual Model

- It allows learners to complete the majority of course online, but attend school for required face-to-face learning sessions.
- It usually don't require daily school attendance.









How to blend?

- 1. List tasks and must knows in clinical setting
- 2. Categorize them into three groups:
 - Should be trained in person
 - Better to be trained in person
 - Could be trained via e-learning strategies



How to blend?

- 3. Determine your tools and facilities
- 4. Select the blending model
- 5. Design the clinical education program, i.e.:
 - Determine the sequence and days of students presence
 - Think of blending e-learning part as well!
 - •



How to blend?

- 6. Ask students' opinion on the program
- 7. Think of students and program evaluation

Minimum physical presence for each level of students in clinical setting

- Target group: pre clerkship students
- Number in each rotation: 10
- Ward: internal medicine

Combination of enriched virtual and flipped model

Virtual part

- Providing the facility to participate in activities like morning reports online
- Case discussion in social media or forums
- E-content on "must knows"
- Collaborative virtual team works
- Some simulations, e.g virtual patient

In person part

 Each learner two days a week planned for must be in person activities
